# **UK LETTINGS SERVICES AND FEES**

At Dolce Vita Lettings, we are transparent about our fees, so you will know upfront exactly what you're paying for. The following is a complete list of our landlord charges and fees. Please note that all fees include VAT, unless otherwise noted.

# LETTINGS SERVICES

# Letting & Rent Collection

Year 1: 11% + VAT (13.2%) fee of total rent due upfront.

Year 2 onwards: 10% + VAT (12%) fee of total rent per year due upfront.

# Short Letting (inclusive of Property Management)

At the start of the tenancy and any renewal/extension, a fee of 26% plus VAT (31.2%) of the agreed rent for the entire term must be paid in full.

# Letting & Property Management

A fee of 17% plus VAT (20.4%) of the agreed rent will be charged. This includes an 11% plus VAT (13.2%) letting and rent collection fee, due in full at the start of the tenancy for the entire initial term, and a 6% plus VAT (7.2%) property management fee, payable as rent is collected.

# Vacant Property Management

£210 per month.

# Works costing less than £500

Will be carried out without consulting the landlord, unless otherwise specified in writing.

#### Works costing more than £500

A fee of 10% plus VAT (12%) of the total cost will be charged as an arrangement fee.

**Additional Property Visits** (2 per year included in service) £96.

# AGREEMENT AND ARRANGEMENT FEES

## **New Tenancy Agreement with** Referencing & Right-to-Rent Fees

£300 payable by the Landlord.

# Tenancy Renewal Agreement fee

£150 payable by the Landlord.

## Deposit Registration fee

£60 payable by the Landlord.

#### Gas Safety Check arrangement fee

£60 plus the cost of the gas safety certificate.

## Portable Appliance Test (PAT) arrangement fee

£60 plus the cost of the PAT test.

# EICR Test arrangement fee

£60 plus the cost of the test.

#### **EPC arrangement fee**

£60 plus the cost of the EPC.

# Legionnaires Assessment arrangement

£60 plus the cost of the assessment.

# Smoke and Carbon Monoxide Alarms Installation Arrangement Fee

£60 plus the cost of the alarm(s) and installation.

## Deposit Dispute Management Fee (In the event a formal dispute must be raised via the DPS)

£240 payable by the Landlord.

## Check In/Check Out and **Inventory Fees**

£250 each (for properties up to 3bedrooms).

### Deposit Transfer administration fee £72.

£60 for a minimum of 6 statements & £6 per additional statement.

## Property Visits/Miscellaneous Duties

£96 per hour.
